Subscription(s)/Membership:

Membership is for one season only commencing on 1st July. Subscriptions are due on the submission and acceptance of this application and must be paid in full by the first game of the season. The rate is set at the Club AGM or adjusted as necessary during the season to keep the club financially viable. Any adjustment, once announced, you agree to pay immediately.

NB: The Club can offer a payment plan for the annual subscription or adjustment that must be agreed with the Club Treasurer. If a payment plan falls into arrears, the outstanding balance becomes payable immediately and could result in the registered player being ineligible to play.

Subscription payments to be made by either:

- i. cheque made payable to Steeple Bumpstead Dynamos reference on the back of the cheque the applicants name and team e.g. Micky M Ouse U8. or by bank transfer to sort code 20-74-05 a/c no. 53757862 (reference as per that for cheques).

Other Terms & Conditions:

- a. To supply visually to one of the Club Officers a legal document (e.g. Birth Certificate, Passport) confirming the age of the person seeking registration.
- b. That essential information taken from this application form is given to team manager/assistant managers (parent's/guardian's contact details) for use in the event of an emergency and in the event of a medical emergency you agree to the registered player receiving any dental, medical (including medication) or surgical treatment as considered necessary by attending qualified medical practitioners. Should you wish to withdraw your consent to this clause please attach a signed declaration accepting full responsibility for your action.
- c. To reimburse the Club any costs incurred as a direct result of the registered player receiving a disciplinary caution in any match of an official competition or Club arranged friendly.
- d. That you make arrangement to return all kit and equipment issued by the club in a clean and useable condition to a Club Official within 2 weeks of the player resigning from the club. Should you fail to fulfil this requirement the Club reserve the right to invoice you for the cost of replacements and recovery of any costs involved in collecting payment.
- e. That the registered player and signatories agree to abide by the 'FA Respect Code of Conduct' (details available on the FA and Club websites).
- f. The Club can on occasions publish photographs on our Facebook account and website that may contain images and the first name only of the player seeking registration. Should you wish to withdraw your consent to this information being published please indicate your preference in the declaration below. (please note that the Club does not accept responsibility for postings made on an individual's own social media or any other communication media)
- g. That you, your immediate family or the player seeking registration does not resort to making disparity remarks aimed at the Club, any club official, committee member, manager, assistant manager or player either verbally or on any social media platform or by text or email. If in the event of any violation of this term the Club Welfare Officer will conduct a full investigation the result of which could result in this registration being cancelled without any refund of any subscription paid either in full or pro-rata.
